- An unmodified copy of the ban notice on the client's account forwarded directly to our discord within a maximum of 10 days from the initial date of account ban along with the e-mail You got from our store after You've bought it;
- The reason for ban must be under "purchase of account" or the substantial equivalent of it;

- There is at least 1 (one) match played on the account following purchase (matchmade or normal game);
- A replacement account has not already been issued for the one purchase. If any or all of these conditions are not met, this warranty service will not apply. We provide customers with replacements, no refunds are made. There is a rule stating you can get one new account as a replacement for one purchase made. Additionally, this service will never apply to circumstances and/or events where the end user (the “Client”) is held responsible for the ban.
